GENERAL RULES & REGULATIONS

1. The Crosby Fair and Rodeo will be held in June.
2. All property and exhibits entered for display, competition for sale, or any purpose shall be subject to the rules of the Crosby Fair and Rodeo and therefore be under the control of the Board of Directors or a committee appointed for that purpose.
3. The Crosby Fair and Rodeo, Board of Directors, has the right to stop, close, or remove any exhibit, animal, stand, show or concession that they may deem objectionable, falsely entered or otherwise considered unsuitable, without assigning a reason thereof.
4. All monies and fees due and payable to the Crosby Fair and Rodeo shall be payable in advance of 8:00 a.m. the first day of the show. Amusements, concessions or exhibit's that are allowed on a commission basis are exempt from this rule.
5. Any expense or attention required from the transporting of any exhibit or display either to or from this fair must be borne by the exhibitor.
6. The violation of any of the rules of this Fair will be considered an automatic forfeiture of all privileges, premiums, or prize money.
7. These General Rules will apply to all divisions for the normal governing of this Fair, unless otherwise stated in division rules. In these instances, the Division Rules will apply, but only to the division in which they appear.
8. Protests concerning the awarding of premium, or unqualified exhibitors or exhibits, false entries, falsification of entry blanks or records will not be accepted more than three days after closing day of the Fair. These protests must be in writing, signed, and a \$100 non-refundable fee paid.
9. Any protest received will be processed at the first meeting after the Annual Fair. At this time, the signer of the protest must present sustaining evidence.
10. The Crosby Fair and Rodeo, its officers, directors, committee members, shall not be held responsible or liable for any loss, damage or injury to any person, persons, or any company or for any property losses or injuries sustained by anyone from any incident or accident on the Crosby Fairgrounds.

GENERAL RULES & REGULATIONS (CONTINUED)

11. The Crosby Fair and Rodeo, Inc. reserves the right to interpret all rules, regulations, and settle all matters, questions and disputes arising out of or in regard thereto and also may amend or add to these rules as they may determine.
12. The Crosby Fair and Rodeo, Inc. has the right to drug test any market animal for non-FDA approved substances or drugs. Only a licensed Veterinarian is allowed to administer treatments or drugs to market animals after arrival at show unless pre-approved by CFR Board of Directors with written Veterinarian approval. Positive test results for non-FDA approved substances will result in forfeiture of all awards, monies, placing's, etc.

13. The Pet Show (if held) will be governed by the Crosby Fair and Rodeo.
14. Online Entries Only will be accepted for market entries, purchase of poultry, open show entries.
15. Absolutely no alcoholic beverages may be consumed in exhibitor areas.
16. No person may discuss the quality of any animals with the judge until the show is complete. Any infraction of this rule could result in immediate disqualification.
17. Any market animal/**Project** exhibitor in local, chapter, town, or other market show excluding Harris County fairs, state, or major shows are not eligible to compete in any market class at the Crosby Fair and Rodeo. Any exhibitor found breaking rule will forfeit winning and showing at Crosby Fair & Rodeo.
18. **All animals - No Branding or manual ID markings, on the lines of freeze branding or hot iron.**
19. **No terminal show animals to exhibit in CFR market class.**
20. **All Exhibitors Thank you cards, including buckles, Open or Market, must be turn in by June 30th. All sale items live and silent must be delivered within 2 weeks of sale and paperwork turned in by June 30th. Failure to meet the deadline will result in a \$50.00 penalty fee that will be deducted from exhibitor's check.**
21. **Exhibitor checks must be picked up within 60 days of designated payout date. Checks that must be reissued will be charged a \$25.00 fee.**

JUNIOR LIVESTOCK SHOW

1. Read General Rules. All entries in this department will be subject to the General Rules and Regulations published in this Premium List, and in addition, the following Special Rules of this department.
2. All Market Exhibitors must be members as of JANUARY 20TH of the current year and be eligible to participate according to the guidelines established by the Crosby 4-H & Crosby FFA. Exhibitors must have conducted their project under the supervision of a 4-H Leader or Ag Teacher. Exhibitors must be currently enrolled in public or private elementary or secondary school and reside within the Crosby I.S.D. Animal projects must be raised within the boundaries of the Crosby ISD during the established feeding periods. No market animals are allowed to be out of the feeding district for more than 3 consecutive days without prior approval from the Crosby Fair & Rodeo. Crosby Fair and Rodeo has the right any time from tag in to show date to visit and inspect all projects.
All eligible exhibitors not enrolled in Crosby ISD must submit a letter to the Board requesting permission to exhibit and get approval prior to validation/entry.
3. All exhibitors will be required to sell a minimum of one book of raffle tickets each year in order to be eligible to participate in all activities of Crosby Fair and Rodeo. Not to include open show exhibitors. There will be a belt buckle awarded for top ticket salesman. Tickets will be available at animal validation or can be picked up at the fair office no later than the first Monday in April. Raffle tickets and money must be turned into the fair office no later than the first Monday of May. Money raised from this raffle will be deposited into a Facility Improvement Account and used exclusively for facility improvements voted on by the board of directors.
4. In all cases the right is reserved to reject or accept conditionally any application for entry. Any ineligible exhibitor attempting to show their projects will be disqualified and monies or trophies will be withheld.
5. The showing of unethically fitted livestock is prohibited. Unethical fitting within the meaning of this rule will be deemed to consist of any method altering the natural confirmation of any part of the animal body, evidenced by presence of abnormal tissue or foreign substance. No grooming adhesives will be allowed to be used, all species. Cable halters are prohibited for all species.

JUNIOR LIVESTOCK SHOW

(CONTINUED)

6. Validation/Entry forms must be turned into the Livestock Chairman with all proper signatures, fees, social security number, and name of school attended on validation date. There will be a maximum 7-day grace period for exhibitors to protest membership in the 4-H and FFA to their organizational leaders.

7. All market steers, swine, lambs, and goats must be in place by 12:00 PM on Monday, June 1, 2026. All poultry must be in designated pen/show area by 6:00 PM on Monday, June 1, 2026.

8. All Market Rabbits must be in place by 3:30 PM on June 1, 2026.

9. Entries must be the bona fide property of the exhibitor. No partnership entries accepted except where both members of the partnership are eligible.

10. Exhibitors may only exhibit one of steer, swine, lamb, and/or goat. Two alternate steers, swine, lamb, or goat per exhibitor may be tagged. Market animals will be designated at weigh in at the show. Immediate family alternates are acceptable. A \$20 fee will be charged for tagging all alternate animals.

11. Exhibitor must furnish feed, feeding and watering equipment for his/her entry.

12. Exhibitors are responsible for cleaning his/her stall, pen, or cage twice daily and dispose of refuse matter. (All Pens will be assigned by the discretion of the Board Members)

JUNIOR LIVESTOCK SHOW

(CONTINUED)

13. All entries in the cattle division must be halter broken and manageable to show and sell by the exhibitor.

14. Only sand and shavings will be allowed as bedding material. No carpet, cardboard, etc.

15. Two showmanship Award will be presented, one for CF& R market entry, and one for Open entry, in the beef, swine, lamb, and meat goat division with a Junior and Senior class per division. Juniors, 13 and under and Seniors 14 and older as of January 1st of the current year. Each exhibitor must show his/her own animal. Substitute exhibitors are not eligible to compete for showmanship.

16. In the event there is only one entry in a class, ribbons will be awarded at the discretion of the judge.

17. No payment for animals sold at Auction will be made to exhibitor until proof of delivery is presented to a 4-H or FFA Leader or the Crosby Fair and Rodeo Association.

18. Exhibitors, parents and guest are not allowed on the grounds after 12:00 AM or before 6:00 AM.

19. Show Management reserves the right to divide and/or combine classes based on the number of entries.

20. Entries from outside the Crosby 4-H and FFA will be accepted as stall space permits.

21. Livestock must be shown by the owner or a substitute must be approved by the Livestock Committee. If the exhibitor is not present at the time of judging, the animal is subject to disqualification. Only exhibitors will be allowed to show animals. No adults. Any Crosby ISD student is eligible to assist/hold in the broiler/turkey show.

22. A TOP HAND AWARD will be presented to one Jr. and one Sr. member of Crosby FFA or Crosby 4-H, for performing above and beyond normal expectations and Participation of the Crosby Fair and Rodeo. Candidates will be selected by members of CF&R Board of Directors.

23. No Market Poultry, Rabbits, and Livestock exhibits may be removed from the show or fairgrounds before 8:00 AM TBD or released by committee chairman, with the exception of out-of-town School District entries, who will be released immediately following judging. All pens must be cleaned by exhibitors before release and removal or the exhibitor will not be allowed to show the following year.

JUNIOR LIVESTOCK SHOW (CONTINUED)

24. The removing or altering of identification tags or marks used by fair officials to distinguish between entries are prohibited.
25. If a Junior Exhibitor is found in violation of any of the Livestock Show rules, He /She and his immediate family may be forever barred from exhibiting livestock at the Crosby Fair and Rodeo.
26. Open Show entries are due by May 28, 2026. Late entries will be accepted with a \$5.00 late charge. CASH ONLY (Rule meant for Crosby FFA and 4-H)
27. Only online entries will be accepted for Market entries and purchase of poultry.
28. For Sale signs may not be displayed until the completion of the Auction. There is to be no intent to sell exhibits until the completion of the auction. (Example, for Sale signs, social media posts, etc.)
29. Fitting, Handling, Culling & Selecting, etc. of livestock may only be done by Crosby Market Animal exhibitors, IMMEDIATE family members of Crosby Market Animal exhibitors residing in their household (Divorced parents are eligible regardless of residence) and Crosby 4-H Leaders or AG Science Teachers after the arrival of the animal on the grounds including parking lots. Past Crosby Market Animal Exhibitors will be allowed to fit. No paid or professional fitters will be allowed.
30. Tack or equipment may be moved in from 5:00 PM – 8:00 PM on Sunday, May 31, 2026
31. Once unloaded at the Crosby Fairgrounds no market animal may leave the exhibit or show area. They may not be loaded in trailers, taken to parking areas, or removed from the grounds. **All animals to remain under show barn at all times with the except of steers who can only go to the arena area.**
32. All substitute exhibitor requests must be submitted in writing to Crosby Fair and Rodeo prior to the first day of the fair.
33. All entries will only be allowed one time across the scales during the weigh in.
34. Entries as "family" are immediate family members of Crosby market animals' exhibitors residing in the same household. Example: Brother, stepbrother; divorced family not in same house. Example: brother with one parent, brother with second parent, meeting rule 2 of JLS.
35. After 11:59pm no parking of Exhibitors or family on South side of drainage ditch Monday night.

SCHOLARSHIP PROGRAM

Up to (5) \$5,000 CFR scholarships and (1) \$2,500 trade school scholarship will be awarded to eligible seniors. Any student that is eligible to show at CFR is eligible to apply for a scholarship. All scholarship applications and deadlines will be administered by Crosby High School Counselor office. If the applicant is not enrolled at CISD then they may pick up and return a scholarship application from the CFR office. CFR will honor the same dates as CISD and it will be the applicant's responsibility to abide by these dates. Unlimited number of scholarships can be given at the discretion of Crosby Fair and Rodeo, if deemed necessary. The recipients should be registered at college, have a record of good character, attendance, and discipline. Recipients must have exhibited livestock, sewing/crafts, foods, horticulture, photography or ag mechanic projects in the Crosby Fair for two years during their four years of high school. Candidates will also be graded on participation at the fairgrounds for community services and improvement events. All applicants must compose a 250 word or more essay relaying how Crosby Fair and Rodeo has had an impact on their life.

1. Up to (5) \$5000 scholarships to students with the goal of obtaining a BACHELOR'S degree from a 4yr institution and (1) \$2500 scholarship to a student pursing a trade school.
2. \$625 for each semester for four years and \$1250 for enrollment into trade school and \$1250 for proof of successful completion form trade school.
3. First semester proof of registration.
4. Subsequent semesters proof of registration and copy of past semester grades presented to Committee for approval.
5. Approval of the Fair Association Scholarship Committee can be used for summer school.
6. In the event that the student drops out or fails out of school, any unused portion of this award reverts back to the Fair Association.
7. In the event that a recipient changes a degree plan from 4 year to 2-year plan, the proceeds will be reduced to \$2500 max.
8. Recipients must maintain a minimum of 12 hrs. per semester, and a minimum GPA of 2.0. Failure to meet the guidelines will result in one semester probation.
9. Any scholarship winner who graduates in four years from a college or university with a degree and chooses to continue their education, upon notification to the Crosby Fair and Rodeo MAY be considered for future scholarship funds. In order to be considered you must present proof of a minimum GPA of 3.25 to the Crosby Fair and Rodeo scholarship committee. You will also be required to submit proof of registration to an accredited college or university graduate program.
10. **Parent or guardian must be a member of CFR for at least 1 year of the applicant being enrolled in Crosby High School or another credited High School equivalent.**
11. Any special case not covered by these rules will be ruled on by the Board of Directors.

AUCTION SALE RULES

1. This sale is limited to projects owned, fed, and cared for by members in good standing of the Crosby 4-H & FFA.
2. The sale may consist of 10 steers, 10 market swine, 10 market lambs, 10 market goats, 10 pens of broilers, 10 turkeys, 10 pens of rabbits, 6 ag mech, 2 horticulture, 2 Sewing/Craft, 2 Food and 2 Photography. Lots may be adjusted up or down according to the number of entries.
3. All eligible entries must sell.
4. Sale commission will be 4% of all Live, Silent, and under barn sales to be deducted from the sale amount. Added donations will be considered part of the sale lot and commissions will be withheld.
5. \$20.00 per sale lot will be deducted for the buyer's pictures.
6. Exhibitors with poultry and rabbits sold through the auction will be required to process their animals if the buyer wants them processed.
7. Poultry and rabbits making the sale must be delivered to the buyer within two weeks of the Fair. A signed release from the buyer must be presented to receive the sale check.
8. All exhibitors will be required to turn in a "Thank You Card" in a stamped envelope addressed to the buyer with the exhibitors return address. **Thank you cards and delivery paperwork with buyers' signature are due in the Fair Office by June 30, 2026.**
Failure to meet the deadline will result in a \$50.00 penalty fee that will be deducted from exhibitor's check.
9. Exhibitors are responsible for the care of sale animals until delivery to the buyer or agent of the buyer.
10. Exhibitors of steers, swine, lambs, and goats are responsible for the loading of their animal onto the correct processor's trailer.
11. Exhibitors and their families may not pursue buyers concerning the donation or buy back of sale animals.
12. No animal per species may bring within \$50.00 of the champion of that species. Ag Mechanics is not included.
13. Any special case not covered by these rules will be ruled on by the Board of Directors.
14. **No Sale Market animals** will be allowed to leave the fairgrounds or be loaded out on Thursday, June 5th, from 10:00 AM—Noon. On Friday, June 6th, the morning after the auction, Custom processors will be loaded out from 8:00AM to 9:00AM with the remainder loaded from 9:00AM to 10:00AM.
15. All market exhibitors will be paid for sale animals on or before the day of the Annual Crosby Fair & Rodeo Membership Feed.
16. Exhibitors will have no alcohol on sale block, sale pictures, or buyer's gifts.

AGRICULTURAL MECHANICS

PROJECT SHOW

ENTRIES DUE: See Dates to Remember on page 8, 9, 10 or 11.

PURPOSE

To provide an opportunity for 4-H and FFA members to display projects constructed -refurbished in Agricultural Mechanics Laboratories and:

- A. To promote the development of skills in agriculture mechanics through competition.
- B. To recognize individual and group accomplishments in the area of agricultural mechanics.
- C. To provide an opportunity for the public to develop an appreciation of this important phase of 4-H and FFA youth programs.

RULES

1. All Agricultural Mechanics Projects are subject to the Crosby Fair and Rodeo Association general rules and regulations.
2. An entry fee of \$20.00 will be charged per project entered.
3. **Open entries in this division are limited to FFA and 4-H members residing in and/or attending an Accredited School in Harris or any County adjacent to Harris County school districts.**
4. Projects exhibited must have been constructed, fabricated, or rebuilt by FFA and 4-H members as a part of their agricultural mechanics instruction in Agricultural Science or as a part of their supervised work experience program.
5. A project can be exhibited only one time at the Crosby Fair and Rodeo and must be constructed fabricated or rebuilt within two calendar years of the exhibition date.
6. Each exhibitor may enter no more than one (1) individually constructed project in market class; no individual exhibitor may enter more than two (2) projects – one in market and one in open. No more than two group projects can be entered and must be in open classes.

AGRICULTURAL MECHANICS PROJECT SHOW (CONTINUED)

7. Each Ag-science class or group of students may enter no more than two (2) class or group constructed projects and may have no more than one (1) entry in any project class.
8. All projects must be clean, painted or treated and in a presentable condition even though they may have been used.
9. A working plan, blueprint or drawing along with photographs showing construction and bill of materials are required to be submitted with each project entered. Description of service performed before and after photos required for reconstructed or refurbished projects.
10. Projects may have been individually, or group constructed, fabricated, or rebuilt and may be individually or chapter owned. Individual projects will be judged as a market class. All group projects will be judged as an open show.
11. Any project that does not fit into one of the stated classes will be disqualified by the committee.
12. All projects are to be identified with standard club exhibitor cards (supplied to Exhibitor's Club or Affiliate). Additional signs, banners, For Sale signs, etc. must be approved by the Committee Chairman.
13. Every precaution will be taken to protect the projects entered; however, neither the Crosby Fair and Rodeo Association nor officials of this Committee will be responsible for any losses or damage to projects.
14. Projects will be judged on the following:
 - A. Workmanship 30 points
 - B. Design & Materials Used 20 points
 - C. Students' Knowledge of Project 20 points
 - D. Degree of Difficulty 10 points
 - E. Plans 10 points
 - F. Finish 10 points

3. Entry fee will be \$20.00 per person/per entry.
4. Classes will be as follows:
Class 1: Cookies (brownie, bar cookies, drop refrigerated, rolled, etc.)
Class 2: Cakes Non-Decorated (layered, cupcakes, bunt, etc.)
Class 3: Cakes or Cookies Decorated (Layered, cupcakes, etc.)
Class 4: Bread (muffins, coffeecake, loaf, etc.)
Class 5: Pies (fruit or double crust, etc.)
Class 6: Candy (fudge, divinity, brittle, etc.)
Class 7: Preserves (fruits, vegetables, jellies, etc.)
5. An exhibitor may enter one entry per class.

1. Any 4-H, FFA or Jr. FFA member in good standing will be eligible to enter.
2. All entries must be paid by **ENTRIES DUE: See Dates to Remember on page 8, 9, 10 or 11.** Entry Fee will be \$20.00 per item entered.
3. Classes will be as follows:
 - Class 1: **ANIMALS - DOMESTIC:** Photos focusing on the various animals that have been tamed and made fit for a human environment. (Dog, Sheep, Pig, Goat, Cow, Cat, Chicken, Horse, Camel, Goose, Ducks (domestic use), Hamsters)
 - Class 2: **ANIMALS - WILDLIFE / AQUATIC:** Photos focusing on animals not tamed or domesticated and commonly found in the wild. (Deer, Snakes, Insects, Rodents, Elephants, Ducks, Fish)
 - Class 3: **NATURE & LANDSCAPE:** Photos focusing on landscapes, outdoor scenic, nature images, sunsets, urban landscapes, seascapes, cityscapes, farms. (Landscapes, Scenic, Outdoors)
 - Class 4: **NIGHT PHOTOGRAPHY:** Photos taken outdoors between after dusk and before dawn. (Fireworks, Lighting on Buildings/ Structures, Animals, Plant/Flora, People)
 - Class 5: **PEOPLE:** Photos focusing on all walks of life, parenting, family, children, babies, sports. (Kids & Family, Models, Sports)
 - Class 6: **PLANT / FLORA:** Photos focusing on interesting unique flowers and flora. Can occur outdoors or indoors. (Rose, Upward shot of a tree, Flower bouquet)
 - Class 7: **FOOD:** Still life photography focusing on attractive photographs of food for use in advertising, packaging, menus or cookbooks. (Thanksgiving dinner, cakes/pies, fruits and place settings. Easter eggs, sandwiches, ingredients.)
4. An exhibitor may enter one entry per class.

PHOTOGRAPHY (CONTINUED)

5. Eligibility: An entry will be disqualified if it does not meet the following requirements.
 - A. Photos must be taken during the current school year.
 - B. Photos must be the original photographic work of the 4-H, FFA member and not taken by family member, other 4-H, FFA members or secured from any other printed / electronic source.
 - C. Photos may be submitted in only one category and only one time.
 - D. Photos must be no smaller than 5x7 and no larger than 8x10.
 - E. Photos can be either portrait or landscape layout.
 - F. Photos can be color or black & white.

- Artwork that smears will be ineligible.
- Artwork must be matted or mounted if the artwork is created on paper.
- If matted, the mat cannot exceed 3 1/2" on any side.
- If matted, the mat must be affixed in a way that it can be removed without damaging the artwork.
- If matted, only use a single mat.
Multiple matting is not allowed.
- If mounted, use a product like tagboard / mat board that is sturdy enough to prevent sagging.
- Wire and / or metal hanging mechanisms must not be attached to the back of the artwork surface.
- Laminated artwork is not allowed.

RODEO ART (CONTINUED)

When artwork is judged: originality, creativity, and composition will be heavily weighted along with the student's ability to apply technical skill and artistic excellence.

1. Originality: is the concept or idea original? Is it the student's own work and / or does the work show interesting composition with multiple sources?

3. Skill: Skill is assessed based on the age of the artist.

Exhibitors must be currently enrolled in public or private elementary or secondary school and reside within the Crosby I.S.D.
3. Registration must be completed online only, and before weigh in **See Dates to Remember on page 8, 9, 10 or 11.**
All Steers must have been weighed in per **Dates to Remember on page 8, 9, 10 or 11.**
4. Steers must weigh at least 600 pounds at tag in and a minimum of 1000 pounds at weigh in at the show and only once across the scales. (Zero lbs Tolerance)
5. All Steers must be dehorned and castrated before tag in in January.
6. All Steers not meeting these standards will be sifted at Show date weigh-in by the Livestock Committee.
7. All Steers must be tagged at weigh-in.
8. There will be only one time across the scales.
9. The Steers must be halter broken and manageable to Show and Sell.
10. Market Steers must be in place by: **See Dates to Remember on page 8, 9, 10 or 11.**
Steer must be designated prior to weigh in, no exceptions.
11. Only Authorized Personnel and exhibitor will be allowed in judging area.
12. No freestanding fans will be allowed in the cattle barn.

Exhibitors must be currently enrolled in public or private elementary or secondary school and reside within the Crosby I.S.D.
3. Exhibitors must have owned swine on or before tag in of the current year.
4. Minimum weight of 220 pounds and maximum of 290 pounds and only one time across the scales.
5. Entries will be divided into weight classes. The number of weight classes will be determined by the Market Swine Committee depending on the number of entries. This will be determined after all swine are weighed in at the show.
6. Tag date will be: **See Dates to Remember on page 8, 9, 10 or 11.**
7. All entries must be castrated before tag-in in March or April.
8. Only Authorized Personnel and exhibitors will be allowed in judging area.
9. All Market Swine must be in place by 12:00 p.m. and weighed in by 2:00 PM.
Official weigh in will be: **See Dates to Remember on page 8, 9, 10 or 11.**
10. No weights will be accepted prior to 1:00 PM.
11. All swine MUST be stalled; 2 per pen, no exceptions, and exhibitors will provide their own dividers.
12. **Ear notch cards will be filled out by exhibitor and verified by 3rd party.**
13. **Remove any tags at tag-in that are not CFR.**

MARKET LAMB DIVISION RULES

1. **May validate three Lambs per exhibitor and immediate family alternates are acceptable.**
2. All market exhibitors must be members as of January 20th of the current year and be eligible to participate according to the guidelines established by the Crosby 4-H & Crosby FFA. Exhibitors must have conducted their project under the supervision of a 4-H Leader or Ag. Teacher. Exhibitors must be currently enrolled in public or private elementary or secondary school and reside within the Crosby I.S.D.
3. Exhibitors must have owned Lambs on or before tag-in of the current year.
4. Lambs must weigh a minimum of 100 pounds at the show (no max weight) and only once across the scales. (3 lb. tolerance)
5. All Lambs must be slick shorn from the knee and hock up at the time of weigh-in at the show, **maximum of 2" tapering of wool is allowed above knee/hock.** Hair length will be checked at time of weigh-in. Any Lamb violating this hair length rule will be given one hour to re-clip their animal and correct their problem. No clipping after weigh-in unless directed by CF&R livestock committee.
6. All Market Lambs will be tagged: **See Dates to Remember on page 8, 9, 10 or 11.**
7. Male Lambs must be castrated before tag-in.
8. Only authorized personnel and exhibitors will be allowed in the judging area.
9. All Market Lambs must be in place by: **See Dates to Remember on page 8, 9, 10 or 11.**
10. The number of weight classes will be determined by the Market Lamb committee depending on the number of entries. This will be determined after all Lambs are weighed in at the show.
11. **Remove any tags at tag-in that are not CFR with the exception of scabies tag.**
12. **Scabies tag must be covered as directed by committee during market show.**

MARKET GOAT DIVISION RULES

1. **May validate three Goats per exhibitor and immediate family alternates are acceptable.**
2. All market exhibitors must be members as of January 20th of the current year and be eligible to participate according to the guidelines established by the Crosby 4-H & Crosby FFA. Exhibitors must have conducted their project under the supervision of a 4-H Leader or Ag. Teacher. Exhibitors must be currently enrolled in public or private elementary or secondary school and reside within the Crosby I.S.D.
3. Exhibitors must have owned Goats on or before tag in of the current year.
4. Goats must weigh between 60 and 135 pounds at the show and only once across the scales. (3 lb. tolerance)
5. **Any female showing signs of being bred will be disqualified.**
6. All Goats must be slick shorn from the knee and hock up at the time of weigh Hair length will be checked at time of weigh-in. Any Goat violating this hair length rule will be given one hour to reclip their animal and correct their problem. No clipping after weigh-in unless directed by CF&R livestock committee.
7. Market Goats must be dehorned or horns must be tipped to no smaller than a dime in diameter at the end.
8. Each exhibitor must be able to show his or her Goat unassisted. Collars are suggested during judging or the showmanship contest.
9. Male Goats must be castrated before tag in. All Market Goats will be tagged: **See Dates to Remember on page 8, 9, 10 or 11.**
10. All Market Goats must be in place by 12:00 pm and weighed-in: **See Dates to Remember on page 8, 9, 10 or 11.**
11. The number of weight classes will be determined by the Market Goat committee depending on the number of entries. This will be determined after all Goats are weighed in at the show.
12. **Remove any tags at tag-in that are not CFR with the exception of scabies tag. Scabies tag must be covered as directed by committee during market show.**

MARKET RABBIT DIVISION RULES

1. Entries are limited to one pen per exhibitor.
2. All market exhibitors must be members as of January 20th of the current year and be eligible to participate according to the guidelines established by the Crosby 4-H & Crosby FFA. Exhibitors must have conducted their project under the supervision of a 4-H Leader or Ag. Teacher. Exhibitors must be currently enrolled in public or private elementary or secondary school and reside within Crosby I.S.D.
3. Exhibitor must own the meat pen at time of Tag-In.
4. After Tag-In the exhibitor agrees to allow the Rabbit Chairman to check meat pen at any time without prior notice. If the exhibitor cannot produce meat pen at that time, the entry will be disqualified.
5. All entries must be free of disease or infection and in good flesh.
6. An entry must consist of three (3) Rabbits not weighing over five.five (5.5) and less than three (3) pounds each, with zero tolerance and only one time across the scales.
7. Weigh-in will be verified by Rabbit Chairman and one Fair Director.
8. Rabbits shall be in place by: **See Dates to Remember on page 8, 9, 10 or 11.**
9. All Rabbits in a pen shall be of the same breed and a breed recognized by the A.R.B.A.
10. Exhibitors only are responsible for the care and feeding of their Rabbits. Any unattended Rabbits will be dismissed from the show.
11. Only authorized personnel and exhibitors will be allowed in the judging area.
12. All Market Rabbits will be released after judging.
13. Judge's decision is irrevocable.
14. All entries must be paid by: **See Dates to Remember on page 8, 9, 10 or 11.**
15. **All Rabbits will be tattooed on: See Dates to Remember on page 8, 9, 10 or 11.**
16. Request for reimbursement of entry fee due to non-kindling of rabbits must be made to the rabbit committee chairman no later than April 29, 2025.
17. Each Exhibitor will be allowed to tattoo 20 Rabbits, if an exhibitor wishes to tattoo more than 20 rabbits there will be a \$2 additional fee per rabbit.

MARKET BROILER DIVISION RULES

1. Entries are limited to one pen of three pullets, cockerels, or mixed sex per exhibitor.

Appendix A for Drug testing/Unethical Fitting

Purpose:

To foster fair competition, to provide a level playing field, to protect the safety of food, and the integrity of Crosby Fair and Rodeo, CF&R strictly Prohibits the showing of unethically fitted livestock, livestock of any ineligible age for exhibition, and/or animals being administered unapproved drugs. Additionally, any animal that has been administered a drug that is not FDA approved for its species is subject to disqualification if that animal tests positive for that drug upon arrival at CF&R grounds. All animals must remain free and clear of all drug and chemical residues while on show grounds.

Non-adherence to Rules: Any person found guilty of misrepresentation or not abiding by the Show rules will be disqualified and denied the privilege of showing Crosby Fair and Rodeo.

Approved Drug Use: If an animal has been administered a drug that is FDA approved for its species and class, sufficient time must have passed so that the animal does not test positive for that drug upon arrival at Crosby Fair and Rodeo (CF&R). Animals must remain free and clear of all drug and chemical residues while on show grounds. See Note H for elimination time.

Animal Inspection: As a condition for participation in the Show an exhibitor must agree to submit any animal entered by the exhibitor for inspection. Exhibitor agrees to have such animal submitted to any tests requested by the Show. Exhibitor also agrees that the opinion reached by the Show or its officials as to whether such animal is unethically fitted shall be final and binding without recourse against the Show or any of its officers. Further, the Show specifically reserves the right to have tissue, blood, urine, hair, feather, and/or fecal laboratory analysis made on any animal entered for competition. The conclusions reached by the laboratory shall be final and binding without recourse against the Show or any of its officers. An exhibitor of an animal that is found to be unethically fitted, and/or testing positive for any drug or medication or unapproved chemical may forfeit all rights and privileges to exhibit livestock in the future at the Show.

Emergency Treatment: If an animal requires emergency treatment while on Show grounds, only a

licensed veterinarian will be allowed to administer any drug, chemical or feed additive. An exhibitor may choose a licensed veterinarian other than the official Show veterinarian, but the official Show veterinarian MUST be notified in advance, and he/she MUST be present. Animals which are administered treatments with a withdrawal or extended elimination time period will be disqualified from competition. Furthermore, The Official Show Veterinarian, in agreement with Show Management, reserve the right to treat any animal if, in the opinion of the Official Show Veterinarian, it is in the best interest of the animal's health and well-being to be treated. If the Official Show Veterinarian administers treatment to an animal and therefore uses any medication that does not meet the appropriate withdrawal and or elimination time, will be determined ineligible for competition.

Treatment Cost: All treatment costs are the responsibility of the exhibitor.

Wholesome Meat Act: The USDA Wholesome Meat Act applies to all market livestock. Only animals eligible for immediate slaughter may be brought onto the grounds and exhibited: Animals must be in good health and carcasses free of drug or chemical residues.

Drug labels must be observed. Please note that elimination time (the time it takes for no drug residue to be found in the system) is generally longer than the labeled withdrawal time for most approved drugs.

If drug or chemical residues are found in tissue of carcasses, the entire carcass may be condemned.

The Crosby Fair and Rodeo will in no way be liable or responsible for the condition of carcasses or the sale price of the animal. In such cases, the exhibitor forfeits all rights to any and all proceeds including. Auction Price, Premium Awards, and Special Awards.

Federal Food, Drug and Cosmetic Act: As required, in 21 CFR 589.2000, entry in the Junior Market swine, lamb and goat shows, and the Junior Commercial Steer competition shall serve as verification by the exhibitor that, to the best of their knowledge, while under their ownership, possession or direct control, the animal(s) were not fed any feed containing ruminant-derived meat or bone meal. Entrants agree to allow packer inspections of feed ingredient records

and facilities.

Disqualification/Condemnation of Animal: "The Show practices a Zero Tolerance policy on all residue violations." The Show reserves the right to condemn and/or disqualify any animal, either live or slaughtered, found in violation the Junior Show Rules and Regulations listed in the handbook and the exhibitor will forfeit all auction sale and/or premium money if the animal is disqualified. If an animal(s) is disqualified, the class placing will not change. A disqualified exhibitor may forfeit all rights and privileges to exhibit livestock in the future at the Show.

Disclaimer of Warranties: CF&R expressly disclaims any express or implied warranties (including merchantability), whether the goods or services are provided by the CF&R or by others (such as drug testing). The CF&R does NOT provide security or guard services and is not responsible for the acts of third parties. Exhibitor and exhibitor's parents and/or guardians agree that the CF&R shall be entitled to disqualify any exhibitor whose animal tests positive for any drug even if the exhibitor and the exhibitor's parents or guardians are innocent of any wrongdoing and had no role in the administration of the drug shown by the drug test. Even if the source of the drug is unknown, the CF&R shall be entitled to disqualify the exhibitor. Disqualification results in forfeiture of all prize money and auction proceeds.

Drug Certification Agreement: Will be the entry to Crosby Fair and Rodeo, online or written entry. Exhibitor and parent/guardian certify that the entry has not been administered or that the exhibitor and parent/guardian do not have any knowledge that this entry has received any substance not approved by the Food and Drug Administration (FDA) and/or the United States Department of Agriculture (USDA) for food animals. Furthermore, the exhibitor and parent/guardian certify that this entry is free and clear of ALL drugs and chemical residue withdrawal and elimination time periods.

Drug Testing: During the collection of blood, feather, fecal, hair and urine samples, the Exhibitor or designated responsible adult must be always present unless a substitute exhibitor is approved by the superintendent. Exhibitors found in violation of this rule are subject to disqualification.

Unethical Fitting: Unethical fitting means any attempt to alter the natural appearance, conformation, musculature, or weight of an animal by any unnatural means. Animals showing any signs of being unethically fitted will be disqualified. Examples of unethical fitting include, but are not limited to the following:

- application of any substance to any part of the animal's body, unless specifically allowed in the department rules of that species; injection, drenching or application of any substance per rectum is prohibited.
- use of injections
- draining of fluids
- bruising
- feeding of material not conducive to the health of the animal, safety of food or marketability of its carcass
- surgical alterations
- **artificially filling animals by airing injections**
